Talmer Cordell SENDS GREETING:

Whereas, I, the said Talmer Cordell

hereinafter called the mortgagor(s) in and by my certain promissory note in writing, of even date with these presents,

hereinafter called the mortgagee(s), in the full and just sum of

SEVEN HUNDRED FIFTY and 00/100 ----- DOLLARS (\$ 750.00), to be paid
one year from date,

, with interest thereon from April 1, 1963
at the rate of six (6%) percentum per annum, to be computed and paid
annually until paid in full; all interest not paid when due to bear
interest at the same rate as principal.

And if any portion of principal or interest be at any time past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole amount evidenced by said note to become immediately due at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including ten (10%) per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

ALL that lot of land situate on the Southwest side of Bertrand Terrace, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 47 on plat of Section A of Mansfield Park, made by Piedmont Engineering Service, December 1960, revised June 1962, recorded in the R. M. C. Office for Greenville County, S. BEGINNING at an iron pin on the Southwest side of Bertrand Terrace at joint front corner of Lots 46 and 47, and runs thence along the line of Lot No. 46, S. 69-00 W., 160 feet to an iron pin; thence S. 32-35 E., 86.9 feet to an iron pin; thence with the line of Lot 48, N. 73-00 E., 136 feet to an iron pin on the South west side of Bertrand Terrace; thence with the curve of Bertrand Terrace (the chord being N. 16-49 W., 95 feet) to the beginning corner.
