ALL that lot of land in the County of Greenville, State of South Carolina, in Fairview Township, being approximately 1-1/2 miles from Simpsonville, S. C., containing 1.3 acres according to a plat of Hoyt Bagwell made by C. H. Riddle dated March 28, 1956, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of the Neely Ferry Road, at the corner of the property herein conveyed and property of Hoyt Bagwell, said pin being in the center of said road and being situate N. 54-30 E. 221 feet from a nail and stopper in the center of a bridge over a creek, and running thence along the center of said road N. 37-20 E. 209 feet to an iron pin at the corner of other property of Hoyt Bagwell; thence S. 43-28 E. 420 feet to an iron pin; thence S. 37-20 W. 209 feet to an iron pin; thence N. 43-28 W. 420 feet to the point of beginning.
