NOW KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums to which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars, \$3.00, if the Mortgagee is ever well and truly paid by the Mortgagee, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns,

All that piece, parcel or lot of land with all improvements thereon or hereafter constructed thereon, situated, lying and being on the Northern side of Wedgewood Avenue in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as a portion of Lot No. 18 as shown on a plat of Croftstone Acres, prepared by W.D. Neves, dated March, 1917, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book E at page 36, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Wedgewood Avenue at the joint front corner of Lots Nos. 18 and 19, and running thence with the line of Lot No. 19 N. 33-35 W. 250 feet to a point; thence in a line parallel to Wedgewood Avenue and in an Easterly direction, 65 feet to a point in the line of property now or formerly of Mary E. McKay; thence with the line of the said McKay property S. 33-35 E. 250 feet, more or less, to a point on the Northern side of Wedgewood Avenue; thence with the Northern side of Wedgewood Avenue in an Westerly direction, 65 feet to the point of beginning.
