All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southern side of Phillips Road near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 3 as shown on a plat of Boiling Springs Estates, dated July, 1961, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book YY at pages 14 and 15, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Phillips Road at the joint front corner of Lots Nos. 2 and 3, and running thence with the line of Lot No. 2 S. 10-17 E. 431.4 feet to an iron pin in the line of property now or formerly of Evelyn H.
