(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of ELEVEN HUNDRED AND NO/100THS-

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Dempsey Street near the City of Greenville, being shown as the southeastern portion of Tract No. 10 on plat recorded in Plat Book D at Page 107, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Dempsey Street and running thence S. 71-04 E. 390.7 feet to pin; thence N. 28-13 E. 203 feet to pin; thence N. 71-04 W. 190 feet to iron pin at rear corner of lot previously conveyed to J. R. Willis; thence with line of said lot S. 28-13 W. 75 feet to pin; thence N. 71-04 W. 200 feet to iron pin on Dempsey Street; thence with Dempsey Street S. 31-50 W. 125 feet to the point of beginning.

Said premises being a portion of the property conveyed to the mortgagor by deed recorded Deed Book 294 at Page 294.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
