Heirs and Assigns, from and against us and our Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same or any part thereof.

And the said G. L. Jordan and Barbara Ann S. Jordan agree to insure the house and building on said lot in the sum of not less than full insurable value

and keep the same insured from loss and damage by fire; and assign the policy of insurance to the said

W. L. Woodson

and that in the event that the mortgagor shall at any time fail to do so, then the said

W. L. Woodson

may cause the same to be insured in his name and reimburse him for the premium and expense of such insurance under the mortgage.

And it is Agreed, by and between the said parties, that should legal proceedings be instituted for the collection of the debt secured hereby, then, and in that event, the said Mortgagor, his successors or assigns, shall have the right to have a Receiver appointed of the rents and profits of the above described premises, with power to forthwith lease out the said premises anew if he should so elect, who, after deducting all charges and expense attending such proceedings and the execution of the said trust as Receiver, shall apply the residue of said rents and profits toward the payment of the debt secured hereby.

And it is Further Agreed, by and between the said parties, that should legal proceedings be instituted for the foreclosure of this mortgage, or for any purpose involving this mortgage, or should the debt hereby secured be placed in the hands of an Agency at Law for collection, by it or otherwise, that all costs and expenses incurred by the Mortgagee, or assigns; including a reasonable counsel fee of not less than ten per cent of the amount involved shall thereupon become due and payable as a part of the debt secured hereby, and may be recovered and collected hereunder.

Provided Always, Nevertheless, and it is the true intent and meaning of the parties to these presents, that we the said mortgagors
