TO ALL WHOM THESE PRESENTS MAY CONCERN: H. J. MARTIN AND JOE O. CHAMPING

(hereinafter referred to as Mortgagor) SEND(S) GREETING.

WHEREAS the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of THIRTEEN THOUSAND FIVE HUNDRED DOLLARS (\$13,500.00) with interest thereon from date at the rate of six (6%) per centum per annum principal and interest to be repaid in monthly installments of One Hundred and Fourteen Dollars (\$114.00) each on the first day of each month hereafter until the principal and interest are fully paid, each payment to be applied first to payment of interest and then to payment of principal and

NOW KNOW ALL MEN That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the signing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the city of Greenville, known and designated as Lot No. 23 as shown on plat of Kendal Green subdivision recorded in plat book XX page 115 of the RMC Office for Greenville County, S. C., and having according to said plat the following lots and bounds, to-wit:

beginning at the joint corner of Lots 22 and 23 on Kendal Green Drive, S. 37-20 E. along Kendal Green Drive 95 feet to joint corner of Lots 23 and 24 on Kendal Green Drive and thence along joint line between lots 23 and 24 N. 52-40 E. 153.4 feet to joint rear corner of Lots 23 and 24, and thence S. 37-15 E. 95 feet to joint rear corner of Lots 22 and 23, and thence along joint line between Lots 22 and 23, S. 52-40 W. 153.1 feet to beginning corner or point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner, it being the intention of the parties hereto that all such fixtures and equipment other than the usual household furniture, be considered a part of the real estate.
