C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

per centum per annum, said principal and interest to be repaid in monthly instalments of

NOW KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situated lying and being in the State of South Carolina, County of Greenville,

being shown as lot # 319, on the southeastern side of Bridgewater Drive, near the City of Greenville, being shown as lot 319, on plat of Sector VII, Botany Woods, recorded in the RMC office for Greenville County in Plat Book YY at Pages 76 and 77, and described as follows:

BEGINNING at an iron pin on the southeastern side of Bridgewater Drive, at the corner of lot 320 and running thence with the curve of the southeastern side of Bridgewater Drive, the chords of which are S. 69-35 W. 69.7 feet and S. 42-30 W. 90.3 feet to iron pin at the corner of lot 61 of Sector II; thence with the line of said lot, S. 49-05 E. 182.4 feet to iron pin; thence N. 66-27 E. 90 feet to iron pin, corner of lot 320; thence with the line of lot 320, N. 28-19 W. 198.8 feet to the point of beginning.
