NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Ridgecrest Drive, known and designated as Lot No. 68 of Vista Hills Subdivision recorded in the R. M. C. Office for Greenville County in Plat Book "P", at Page 149 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Ridgecrest Drive, joint front corner of Lots Nos. 67 and 68 and running thence along the common line of Lots Nos. 67 and 68, N. 39-15 W. 180 feet to an iron pin, joint rear corner of Lots Nos. 67 and 68; thence along the rear line of Lot No. 68 S. 50-14 W. 77 feet to an iron pin; thence along the common line of Lots Nos. 68 and 69 S. 39-15 E. 179.4 feet to an iron pin on the northern side of Ridgecrest Drive; thence along said Drive, N. 50-45 E. 77 feet to an iron pin, the point of beginning.
