WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Eight Thousand Eight Hundred and No/100th**-----

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situated, lying and being **on the Southeastern side of County Cork Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 66 as shown on a Revision of Extension of Shamrock Acres, prepared by Carolina Engineering & Surveying Co., dated August 9, 1963, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book RR at page 133, and having according to said plat the following metes and bounds:**
