All of those parcels or lots of land with all improvements thereon, in the City of Greer, Chick Specings Township of Greenvilla County, State of South Carolina, lying between the Brushy Creek R ad and James Street and on the west side of South Main Street, being all of lots Nos. 1, 2, 3,4 and 7, and also a lot designated as J.M. McHugh lot, all shown on a plat of property made for Mrs. E.A. Wood Estate by H.S. Brockman, Burveyor, dated June 22, 1935, recorded in the R.M.C. Office for preceding County, having the following courses and distances, to wit:
