All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known as Lot No. 3 on plat of Shenrock Acres, recorded in plat book YY at page 43, and having the following metes and bounds, to-wit:
