TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Willie B. West and Irene

G. West, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Seventy-five Hundred** DOLLARS (\$ 7500.00 ), with interest thereon from date at the rate of **Six (6%)** per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 4 in what is known as LAKE VIEW HEIGHTS, property of Mrs. Bessie and I.M. Wood Estate, shown on a subdivision and plat of same made by H.S. Brockman, Registered Surveyor, dated November 2, 1959, said plat being of record in the R.M.C. Office for Greenville County in Plat Book RR, page 19, and having the following courses and distances, to-wit:

BEGINNING at an iron pin in line of State Highway No. 14, joint front corner of Lots Nos. 4 and 5, and running thence S. 71-04 E. 164.2 feet to an iron pin at the joint rear corner of Lots Nos. 4, 5, 10 and 11; thence N. 7-11 E. 95 feet, more or less, to an iron pin in southern line of Woodfield Drive; thence along the line of said Woodfield Drive, N. 72-25 W. 139 feet, more or less, to an iron pin in line of State Highway No. 14; thence along the line of said highway, S. 22-44 W. 89.3 feet to an iron pin at the beginning point.

This is the same property conveyed to the mortgagors herein by E. Inman, Master of Greenville County, by deed recorded in Deed Book 700, page 541, R.M.C. Office for Greenville County.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
