BEGINNING at an iron pin in the center of Murrell Road at the joint front corner of property of Grantor and Lamar Reaves and running thence S. 0-45 E. 281.5 feet to an iron pin; thence with other property of the Grantor, N. 51-45 W. 178 feet to an iron pin in the center of Murrell Road; thence with said Murrell Road, the following courses and distances: N. 31-0 E. 29.2 feet to an iron pin; thence N. 37-39 E. 160 feet to an iron pin; thence N. 48-35 E. 31 feet to the point of beginning."
