in the full and just sum of Twenty-Seven Hundred Ninety-Eight and 95/100
- - - dollars, to be paid \$18.00 per week until paid in full
beginning January 11, 1964,

, with interest thereon from maturity
at the rate of 7 per centum per annum, to be computed and paid annually
until paid in full; all interest not paid when due to bear
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bar-
gained, sold and released, and by these Presents do grant, bargain, sell and release unto the said
J. C. Roper, d.b.a., Southern Motor Finance Company, his heirs and
assigns, forever:

All that piece, parcel or lot of land situate, lying and being near
the City of Greenville, County of Greenville, State of South Carolina,
and known and designated as Lot No: 7, part of Sharon Park, according
to a plat by C. C. Jones, dated April 1955, and a revised plat of May
1956, plat of which is recorded in the R.M.C. Office for Greenville
County, in Plat Book "EE", page 130, and according to said plat, having
the following metes and boundar:

BEGINNING at an iron pin at joint front corner of Lots #6 and #7,
running thence along the line of these lots, N. 60-29 E. 150 feet to
an iron pin; running thence N. 14-40 W. 77 feet to an iron pin on the
southern side of Sharon Drive; thence along the southern side of Sharon
Driver, S. 75-20 W. 150 feet to an iron pin at an intersection; thence
along said intersection, which intersection is curved, the chord of
which is S. 22-47 W. 30.4 feet to an iron pin on the eastern side of
