Laura A. James, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, in the City of Greer, and being more particularly described as Lot No. 40 on a plat entitled "Subdivision for McCall Manufacturing Company, Greer, S.C.," prepared by Pickell & Pickell, Engineers, Greenville, S.C., dated May, 1949, and recorded in Plat Book S, page 76, R.M.C. Office for Greenville County. This lot is also known as No. 103 Frankline Street (now Delano Avenue), and fronts thereon 96 feet.

This is the same property conveyed to the mortgagors herein by G.V. Hanna, by deed recorded in Deed Book 706, page 117, R.M.C. Office for Greenville County.
