(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, having the following metes and bounds, to-wit:

BEGINNING at a stake on White Horse Road, and running thence N. 28-1/2 E. 45.06 chains to stake; thence N. 82-30 E. 4.85 chains to a stake; thence S. 34 E. 4.12 chains to a stake; thence S. 28-1/2 W. 44.56 chains to a stake on White Horse Road; thence up said road, N. 64-1/4 W. 6.00 chains to a stake; thence continuing with said road, N. 68 W. 2.15 chains to point of beginning, containing 37 acres, more or less.

This being the same premises conveyed to James E. Hawkins and Evelyn Reid Hawkins by deed recorded in Deed Book 407 at page 515, the said James E. Hawking having conveyed his undivided one-half interest to the mortgagor, Evelyn Reid Hawkins, by deed recorded in Deed Book 695 at page 357.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
