MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

THE COMPRESSOR CORPORATION OF AMERICA SEND GREETING:

WHEREAS it the said The Compressor Corporation of America is indebted unto SOUTHLAND LIFE INSURANCE COMPANY, of Dallas, Texas, by its promissory note, in writing, of even date herewith, of which the following is a copy:

\$ 29,000.00 Greenville, South Carolina, January 3, 19 64 .  
"For value received, it promises to pay to the order of SOUTHLAND LIFE INSURANCE COMPANY the principal sum of Twenty-Nine Thousand (\$29,000.00) - - - - - Dollars, with interest thereon from date hereof at the rate of six per cent. per annum, said interest and principal sum to be paid in installments as follows:

"Beginning on the 3rd day of February, 19 64, and on the 3rd day of each month thereafter, the sum of Two Hundred Eighty-three and 04/100 (\$283.04) - - - - - Dollars, to be applied on the principal and interest of this note until the 3rd day of January, 1976, when any balance remaining due on principal, with accrued interest, shall be payable in full. The aforesaid monthly payments of Two Hundred Eighty-three and 04/100 (\$283.04) - - - - - Dollars each are to be applied first to interest at the rate of six per cent. per annum on the principal sum of Twenty-nine Thousand (\$29,000.00) - - - - - Dollars, or so much thereof as shall from time to time remain unpaid, and the balance of each monthly payment shall be applied on account of principal; all installments of principal and interest of this note being payable at the Home Office of the SOUTHLAND LIFE INSURANCE COMPANY, Southland Center, Dallas, Texas, in lawful money of the United States of America.

"This note and the interest are secured by a mortgage on real estate of even date herewith, duly recorded in the office of the Clerk of Court for Greenville County, South Carolina.

"If this note is placed in the hands of an attorney for collection, by suit or otherwise, or to enforce its collection, or to protect the security for its payment, it will pay all costs of collection and litigation together with a ten (10%) per cent. attorney's fee.

"All installments of principal and interest of this note shall bear interest after the due date at the rate of six (6%) per cent. per annum.

"Upon failure to pay an installment of principal and interest of this note within fifteen days after due, then the remaining installments of interest and principal secured by said mortgage shall at once become due and payable, at the option of the legal holder hereof.

"The makers and endorsers severally waive demand, presentment, protest and notice of protest and expressly agree that this note, or any payment thereunder, may be extended from time to time without in any way affecting the liability of the makers and endorsers hereof.

"The payment of this note may be anticipated in whole or in part at any time, ~~but no payment shall be made prior to the date of the maturity of the note.~~

NOW, KNOW ALL MEN, That it the said mortgagor in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said SOUTHLAND LIFE INSURANCE COMPANY, of Dallas, Texas, according to the terms of the said note and also in consideration of the further sum of THREE DOLLARS to it the said mortgagor

in hand well and truly paid by the said SOUTHLAND LIFE INSURANCE COMPANY at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said SOUTHLAND LIFE INSURANCE COMPANY:

All those certain pieces, parcels and lots of land situate on the Southeast side of Augusta Street, shown as property of C. K. Hammond prepared by Piedmont Engineering Service, April, 1954, recorded in the Office of the R.M.C. for Greenville County in Plat Book HH, page 57, and having, according to said plat, the following metes and bounds, to wit:

Beginning at a point on the Southeast side of Augusta Street, said point being 114.75 feet Northeast from the Northeast side of University Ridge, and running thence along Augusta Street, N. 38-44 E. 25.15 feet to a point; thence continuing with Augusta Street
