To ALL WHOM THESE PRESENTS MAY CONCERN:

We, Malvin W. Edwards and Audrey H. Edwards of Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that piece, parcel or lot of land situate, lying and being on the Southern side of Lee Road near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 3 of the Rachel Burns property and, according to a plat prepared by R.B. Bruce in February, 1964, has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Lee Road, which iron pin is 415.2 feet east from the intersection of Lee Road and Mayfair Drive and running thence with the Southern side of Lee Road, N. 62-15 E. 100 feet to an iron pin; running thence S. 09-0 E. 220 feet to an iron pin; running thence S. 62-15 W. 100 feet to an iron pin; running thence N. 09-0 W. 220 feet to an iron pin, point of beginning.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
