reference, in the sum of Seven Thousand and no/100 ----

DOLLARS (\$ 7,000.00), with interest thereon from date at the rate of 6 1/2% per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, containing 2.44 acres, more or less, and being a portion of that property shown on Plat of Grace Greer recorded in Plat Book "FF", Page 514, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the center of S. C. Highway 293 (also referred to as S-91) which is a road running between S. C. Highway 415 and S. C.
