ALL that lot of land situate in Chick Springs Township, Greenville County, South Carolina, being shown and designated as Lot No. 109 of Piedmont Estates, a plat of which is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book KK, page 45, said lot fronting on Churchill Avenue a distance of 60 feet and running back for a depth of 175 feet.

It is understood that the within Mortgage is a Junior Lien.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
