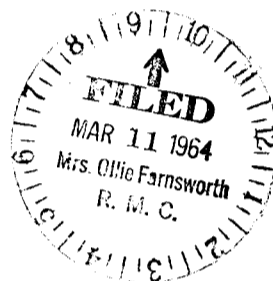
That **REPUBLIC CONSTRUCTION COMPANY, INC.**
