TO ALL WHOM THESE PRESENTS MAY CONCERN:

Bernard H. Titchener and Kathleen B. Titchener of
Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto **CAMERON-BROWN COMPANY**,

, a corporation
organized and existing under the laws of **North Carolina**, hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of **Fourteen Thousand Fifty and**
00/100 -----Dollars (\$ **14,050.00**), with interest from date at the rate
of **Five and one-fourth** per centum (**5 1/4** %) per annum until paid, said prin-
cipal and interest being payable at the office of **Cameron-Brown Company**

in **Raleigh, North Carolina**
or at such other place as the holder of the note may designate in writing, in monthly installments of
Seventy Seven and 70/100 -----Dollars (\$ **77.70**),
commencing on the first day of **May**, 1964, and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of **April**, 19 **94**.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of **Greenville**,
State of **South Carolina**:

ALL that lot of land with the buildings and improvements thereon, situate
on the North side of **Butternut Drive**, near the City of **Greenville**, in
Greenville County, S. C., being shown as **Lot No. 18** on Plat of **Chestnut**
Hills, made by **R. K. Campbell**, Surveyor, **March 1954**, recorded in the **R.**
M. C. Office for Greenville County, S. C., in Plat Book **GG**, at Pages **34**
and **35**, said lot fronting **70 feet** along the North side of **Butternut**
Drive; running back to a depth of **146.8 feet** on the East side; to a depth
of **138.25 feet** on the West side; and being **60 feet** across the rear.

to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against
the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
