NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and
of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his
account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly
paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has grant-
ed, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and as-
signs:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and
being in the State of South Carolina, County of Greenville on the north side of a county road that leads from
Double Springs Church to Milford Church (known as the McElhaneey road in O'Neal Township,
containing two (2) acres, more or less, and having the following courses and distances, to wit:
BEGINNING at an iron pin on the north side of said road, corner of the Page land and running
thence N. 12-45 E 716.8 feet to an iron pin, thence N. 89-45 E. 125 feet to an iron pin, thence
S 12-45 W 716.8 feet to an iron pin on the north side of said road, thence with the north side
of said road S. 89-45 W 125 feet to the beginning point. This being the same property which was
conveyed to mortgagors herein by M. S. Tate by deed dated July 9, 1958, and which deed will be

fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances
except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the
Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
