Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville ,

All that certain piece, parcel, or lot of land with the buildings and improve-
ments thereon, lying and being on the easterly side of Mayfair Lane in the City of
Greenville, S. C. being known and designated as Lot No. 31 on plat of Holmes Acres,
as recorded in the RMC Office for Greenville County, S. C. in Plat Book Z, page 1.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
