

Parcel No. 2

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being in Butler Township near the City of Greenville, S. C., on the northeasterly side of S. C. Highway #291 near to and easterly from the White Oak Road and being the eastern portion of Lot No. 3 on the plat of Matthews Property made by Dalton & Neves, dated September 1949, and having according to a survey made by Dalton & Neves, dated September 15, 1951, the following metes and bounds, to-wit:

BEGINNING at an iron pin the center of the Duke Power right of way on the northeast side of South Carolina Highway No. 291 and running N 72-39 E 289.3 feet to an iron pin; thence S 4-24 W 67.9 feet along Kinney property line to an iron pin; thence S 49-09 W 216.9 feet to an iron pin on said highway; thence N 40-51 W 163 feet along said highway to the point of beginning.

Parcel No. 3

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the northeasterly side of Old Buncombe Road, near the City of Greenville, S. C., and having according to a plat entitled Property to C. E. Willis made by Jones & Southerland, dated September 21, 1960, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Old Buncombe Road which iron pin is the joint corner of the property herein described and Union Bleachery and running thence along Old Buncombe Road S 63-53 E 160.4 feet to an iron pin; thence N 26-07 E 100 feet to a point; thence N 63-53 W 94.7 feet to a point in the line of the property now or formerly of Union Bleachery; thence S 59-18 W 119.2 feet to the point of beginning.

Parcel No. 4.

All that piece, parcel or lot of land situate, with the buildings and improvements thereon, lying and being in the County of Greenville, State of South Carolina, on the southwestern side of Cedar Lane Road (also known as Highway #416) and being known and designated as Lot No. 3 and a portion of Lot No. 2 of Block A of Grand-View Heights as shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book "BB", at page 38 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Cedar Lane Road at the joint front corner of Lots Nos. 3 and 4 and running thence along the joint line of said Lots, S 45-03 W 215.3 feet to a point in the center line of Old Cedar Lane Road; thence along the center line of said old road, S 60-00 E 86.2 feet to a point; thence continuing along the center line of said road, S 68-59 E 19 feet to a point; thence with a new line through Lot No. 2 N 45-03 E 180 feet, more or less, to a point on the southwestern side of Cedar Lane Road, which point is 7 feet in a southeasterly direction from the joint front corner of Lots Nos. 2 and 3 and running thence along the southwestern side of said road N 44-57 W 100 feet to the point of beginning.

Parcel No. 5

All that certain parcel or lot of land with the buildings and improvements thereon, situated at the intersection of State Highway No. 14 and the Buncombe Road, at Pleasant Grove Baptist Church, about 1 mile southwestward from the City of Greer, in Chick Springs Township, Greenville County, State of South Carolina, and having courses and distances according to survey and plat by W. P. Morrow, Registered Surveyor, dated May 23, 1955, as follows, to wit:

BEGINNING at an iron pin at the north side of the intersection of State Highway No. 14 and the Buncombe Road, and running thence along said State Highway No. 14, N 4-42 W 178.5 feet to an iron pin; thence S 67-20 W 83.2 feet to an iron pin on edge of Buncombe Road; thence along said Buncombe Road S 31-55 E 172 feet to the beginning corner.

Parcel No. 6

All of that parcel or lot of land with the buildings and improvements thereon, in the City of Greer, Chick Springs Township of Greenville County, State of South Carolina, located in the southwest corner of intersection of South Main Street and Pennsylvania Avenue, known and designated as Lot No. 1 on a plat of property made for the I. K. Robison Estate by W. A. Christopher, Surveyor, dated December 13, 1921, recorded in the RMC Office for Greenville County in Plat Book "F", page 157, and having the following courses and distances, to-wit:

BEGINNING on an iron pin at the southwest intersection of said streets, and runs thence with the margin of South Main Street, S 23-25 W 60 feet to an iron pin; thence with the common line of Lots Nos. 1 and 2, N 82-35 W 220 feet to an iron pin; thence

Parcel No. 6 Continued:

N 12-15 E 60 feet to an iron pin on the south side of Pennsylvania Avenue, thence with the margin of this Street; S 82-35 E 231.7 feet to the beginning corner, and being all of that property conveyed to the mortgagor by Floyd S. Rushton by deed dated July 24, 1957, recorded in Deed Book 585, page 217.
