with interest thereon from date at the rate of 7 per centum per annum, to be computed and paid monthly, as stated above, until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agree(s) to pay all costs and expenses including a reasonable amount as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor(s) paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee,

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as lot Number 3 on plat of G.D. Collier property, according to plat made by H.S. Brockman, May 21, 1947, and entered for record in the R.M.C. Office for Greenville County on June 17m 1947, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at a point on the northeast side of Dan Street, joint corner of Lots Nos. 2 and 3, and running with Dan Street N. 80-00 W. 56.5 feet to corner of Lot No. 4; thence with line of Lot No. 4 N. 10-00 E. 100 feet to joint rear corner of said lots; thence S. 80-00 E. 56.5 feet to corner of lot No. 2; thence with line of Lot No. 2 S. 10-00 W. 100 feet to the beginning corner.
