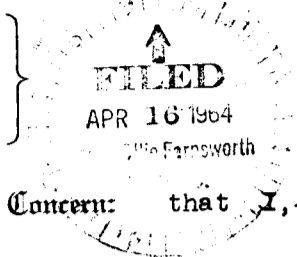

To All Whom These Presents May Concern: that I,-- Hazel C. Edwards,
