C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Seven Thousand Five Hundred and no/100**

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville, in Bates Township, being shown and designated as Lot No. 2 of Mountain View Acres, and according to plat made by Jones & Sutherland, Engineers, recorded in Plat Book 22 at page 3 in the R. M. C. Office for Greenville County, having the following metes and bounds, to-wit:**
