TO ALL WHOM THESE PRESENTS MAY CONCERN: **We, Gerald J. Cronin and Doris Hudson Cronin,** (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the north side of Highland Drive in the City of Greer, and being a portion of Lot No. 76 of the Geanie Caldwell property, plat recorded in Plat Book X, page 1, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING on an iron pin on the north margin of Highland Drive, and running thence with said Drive, S. 58-20 E. 150 feet; thence N. 31-40 E. 172 feet to an iron pin; thence N. 61-46 W. 150.3 feet to an iron pin; thence S. 31-40 W. 163 feet to the beginning corner.
