WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of - - - - - TWENTY EIGHT THOUSAND AND NO/100THS- - - - - -DOLLARS (\$ 28,000.00 ), with interest thereon at the rate of **six (6%)** per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is ~~twenty~~-**five** years after the date hereof, *MAR 77* unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **situate on the east side of Parkins Mill Road, in the City of Greenville, being shown as Lot No. 9 on plat of Section C of Gower Estates recorded in Plat Book YY at page 113 and described as follows:**

BEGINNING at an iron pin on the east side of Parkins Mill Road at joint front corner of Lots 8 and 9 and running thence along the line of Lot No. 8, N. 74-26 E. 250 feet to an iron pin; thence S. 15-34 E. 131.4 feet to an iron pin on the north edge of Stone Haven Drive; thence with the north edge of said Drive, S. 62-26 W. 230.6 feet to an iron pin; thence with the curve of said Drive and Parkins Mill Road, the chord being N. 66-34 W. 31.5 feet, to an iron pin on the east side of Parkins Mill Road; thence along Parkins Mill Road, N. 15-34 W. 155 feet to the beginning corner.
