WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Western side of Washington Avenue and being shown and designated as Lot No. 1 on the plat of the property of L. O. Patterson, recorded in Plat Book K at page 128 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Western side of Washington Avenue at the corner of the Remus Rouda lot and running thence S. 80-13 W. 244 feet to an iron pin at the rear corner of Lot 18; thence with the line of Lot 18, N. 3-55 W. 38.3 feet to a pin at the rear corner of Lot 2; thence with the line of Lot 2, N. 75-07 E. 228 feet to a pin on the Western side of Washington Avenue; thence with the Western side of Washington Avenue, S. 22 E 60 feet to the point of beginning.

Being the same property conveyed to the mortgagor by deed recorded in Deed Book 432 at page 96.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
