All that lots of land in the County of Greenville, State of South Carolina
by the larger portion on lot four #4 on Plat of property of E. D. Cobb
made by C. O. Riddle R.L.S., May 1956 on North side on Stonewall Lane
and being more particularly designated as follows: By an iron pin
on the North Side of Stonewall Lane which point is North 77-09 W. One
Hundred Fifty Six Feet (156') Ft. from the end of the curveture of the
intersection of Stonewall Lane and Shannon Dr. and more thence with
the North side of the curve of Stonewall Lane. The Chord of F, N. 89-
49 W. Twenty Two and Two tenths (22.2') Ft. to an iron pin thence
continuing with the North side of said street S. 68-33 W. Fifty (50')
Ft. to an iron pin at the joint front corner of lot four (4) and Lot
