"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, all the northeastern side of Scuffletown Road and having according to plat of the property of L. A. Fowler, made by W. J.
