GREENVILLE COUNTY, S. C. , hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto CAMERON-BROWN COMPANY

, a corporation  
organized and existing under the laws of SOUTH CAROLINA , hereinafter  
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which  
are incorporated herein by reference, in the principal sum of FOURTEEN THOUSAND AND  
No/100----- Dollars (\$ 14,000.00 ), with interest from date at the rate  
of FIVE AND ONE FOURTH per centum ( 5 1/4 % ) per annum until paid, said prin-

or at such other place as the holder of the note may designate in writing, in monthly installments of  
SEVENTY SEVEN AND 42/100----- Dollars (\$ 77.42 ),  
commencing on the first day of JULY , 1964 , and on the first day of each month there-  
after until the principal and interest are fully paid, except that the final payment of principal and interest,  
if not sooner paid, shall be due and payable on the first day of JUNE , 1994.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better  
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three  
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of GREENVILLE ,  
State of South Carolina:

ALL THAT CERTAIN PIECE, PARCEL OR LOT OF LAND, SITUATE,  
LYING AND BEING ON THE NORTHEASTERN SIDE OF PINE RIDGE DRIVE IN  
GANTT TOWNSHIP, NEAR THE CITY OF GREENVILLE, BEING SHOWN AND DE-  
SIGNATED AS LOT No. THIRTY FIVE (35) OF PLAT 1, SECTION 2, AS  
SHOWN ON MAP OF FRESH MEADOW FARMS MADE FOR L. A. MOSELEY AND C.

had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter  
attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and  
assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple  
absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the
