"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **on the southern side of Lanewood Drive, near the City of Greenville, being shown as Lot 53 on a plat of Pineforest recorded in Plat Book QQ at page 107 and described as follows:**

**BEGINNING at an iron pin on the southern side of Lanewood Drive 439.8 feet west from Oakforest Drive, at the corner of Lot 52 and running thence with the southern side of said Drive S. 63-30 W. 100 feet to an iron pin at corner of Lot 54; thence with the line of said lot S. 26-30 E. 138 feet to an iron pin at the corner of Lot 105; thence with the line of said lot N. 63-30 E. 100 feet to an iron pin at the corner of Lot 52; thence with the line of said lot N. 26-30 W. 138 feet to the beginning corner.**

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
