Beginning on the 1st. day of July, 1964, and on the 1st. day of each month thereafter, the sum of Three Hundred Twenty-Nine and 31/100 (\$329.31) Dollars, to be applied on the principal and interest of this note until the 1st. day of June, 1974, when any balance remaining due on principal, with accrued interest, shall be payable in full.
