"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

**shown as lot # 196 on a plat of Botany Woods, Sector IV, recorded in the RMC office for Greenville County in Plat Book YY at Page 23, and being further described according to said plat as follows:**

**BEGINNING at an iron pin on the northeast side of Bridgewater Drive, at the joint front corner of lots # 197 and 196, and running thence with the line of lot 197, S. 76-30 W. 194.5 feet to iron pin in line of lot 84; thence with the line of lot 84, N. 17-35 W. 142.1 feet to an iron pin on the northern side of Hearthstone Lane; thence along Hearthstone Lane, N. 77-04 E. 176.1 feet to iron pin; thence along the curve of the intersection of Hearthstone Lane and Bridgewater Drive; the chord of which is N. 59-00 W. 36.0 feet to iron pin on the northeast side of Bridgewater Drive; thence along Bridgewater Drive, N. 14-56 W. 115.0 feet to the point of beginning.**
