NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near Travelers Rest, and being known and designated as Lot No. 32 as shown on a revised map of Lots Numbers 34 through 47 of a subdivision known as Meadowbrook Farms, a plat of which is of record in the RMC Office for Greenville County in Plat Book PP at Page 113, and having the following metes and bounds:

BEGINNING at a point on the Southern side of Toler Road at the joint front corner of Lots 31 and 32 and running thence S. 3-00 W. 151.3 feet to a point at the joint rear corner of Lots 31 and 32; thence S. 87-00 E. 100 feet to a point at the joint rear corner of Lots 32 and 33; thence N. 3-00 E. 151.3 feet to a point on the Southern side of Toler Road, N. 87-00 W. 100 feet to the point of Beginning.
