NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville ,
State of South Carolina:

All that certain piece, parcel or lot of land, with the buildings and improve-
ments thereon, lying and being on the northerly side of Rollinggreen Road, near the
City of Greenville, South Carolina, being known and designated as the major portion
of Lot No. 46 on plat of Wellington Green, as recorded in the RMC Office for Green-
ville County, South Carolina in Plat Book YY, page 29, and having according to said
plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Rollinggreen Road, said pin
being the joint front corner of Lots 46 and 47, and running thence with the common
line of said Lots N 30-44 E 145 feet to an iron pin, joint corner of Lots 45, 46 and
47; thence S 60-43 E 146.9 feet to an iron pin on the northwesterly side of Rollinggreen
Road; thence with the northwesterly side of Rollinggreen Road S 6-26 W 16 feet to an
iron pin; thence continuing with said Road S 45-12 W 75 feet to an iron pin; thence
S 81-54 W 70 feet to an iron pin; thence N 75-55 W 80 feet to an iron pin, the point

ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and
assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple
absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the
premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants
to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against
the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
