securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, its
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina: on the eastern side of Tindal Road and being known and designated
as Lot No. 88 on Map No. 5 of Sans Souci Heights, recorded in the R. M. C. Office
for Greenville County in Plat Book "Z", at Page 95 and having the following metes
and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Tindal Road at the joint
front corner of Lots Nos. 88 and 89 and running thence along said Road N. 18-25 E.

assigns forever.

absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the

the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
