WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southern side of DeOyley Avenue in Gantt Township, City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 30, Augusta Road Ranches, as shown on a plat prepared by Dalton & Neves, dated April, 1941, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book M at page 47 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of DeOyley Avenue 480 feet Southwest of the Southwest corner of the intersection of DeOyley Avenue with a 15 foot alley at the joint front corner of Lots Nos. 30 and 31 and running thence with the line of Lot No. 31 S. 0-13 E. 200 feet to an iron pin on the line of property now or formerly of Robert Woodside; thence with the line of said Woodside property N. 89-47 E. 60 feet to an iron pin at the joint rear corner of Lots Nos. 29 and 30; thence with the line of Lot No. 29 N. 0-13 W. 200 feet to an iron pin on the Southern side of DeOyley Avenue; thence with the Southern side of DeOyley Avenue S. 89-47 W. 60 feet to the point of beginning.
