TO ALL WHOM THESE PRESENTS MAY CONCERN: B. F. Burns and Viola H. Burns

Greenville County, S. C. , hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto Cameron-Brown Company

, a corporation  
organized and existing under the laws of North Carolina , hereinafter  
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which  
are incorporated herein by reference, in the principal sum of Thirteen Thousand Two Hundred  
Fifty -----Dollars (\$13,250.00 ), with interest from date at the rate  
of five & one-fourth per centum ( 5¼ %) per annum until paid, said prin-  
cipal and interest being payable at the office of Cameron-Brown Company  
in Raleigh, North Carolina  
or at such other place as the holder of the note may designate in writing, in monthly installments of  
Seventy-three and 27/100 ----- Dollars (\$ 73.27 ),  
commencing on the first day of August , 19 64, and on the first day of each month there-  
after until the principal and interest are fully paid, except that the final payment of principal and interest,  
if not sooner paid, shall be due and payable on the first day of July , 19 94

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better  
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three  
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of Greenville,  
State of South Carolina:

All that lot of land in the county of Greenville, known and desig-  
nated as Lot No. 37, Section 3 of Lockwood Heights subdivision shown  
on plat thereof recorded in plat book XX at page 11 recorded in the  
RMC Office for Greenville County, said lot having a frontage of 95  
feet on the northeast side of Blue Mist Drive, a depth of 154 feet  
on the north side, a depth of 163.6 feet on the south side, and a  
rear width of 95.5 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-  
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
