To All Whom These Presents May Concern:

SEND GREETING:

Whereas, We, the said Loure Murray and Veleah Murray in and by a certain promissory note in writing, of even date with these Presents, we are well and truly indebted to John W. Norwood, III in the full and just sum of Nine Thousand and No/100 Dollars, to be paid \$50.00 per month beginning July 10, 1964, and on the 10th of each month thereafter until paid, principal payable one year from date.

, with interest thereon from date at the rate of 6 per centum per annum, to be computed and paid \$50.00 per month beginning July 10, 1964 and on the 10th of until paid in full; all interest not paid when due to bear each month thereafter interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Murray at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said

John W. Norwood, III, his heirs and assigns forever all that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, and designated by a plat which was prepared in May 29, 1964, by J. C. Hill, Surveyor, and recorded in Plat Book FFF-134, and having, according to the said plat, the following metes and bounds.

BEGINNING at an iron pin, the joint front corner of the property of Flosie Bonner and the grantees herein, and running N 13-05 E 389.8 feet to a stone and iron pin; thence S 8-15 E 338.5 feet to an iron pin on By-Pass 291, this as the joint corner of the property of the grantees herein and Homer Styles; thence S 75 W 148.5 feet to the point of beginning.

This is the same property conveyed to Luella Shloeman by Loure Murray which is recorded in Deed Book 618, at page 248 in the R. M. C. Office in and for Greenville County, State of South Carolina.
