Douglas Wilson & Co., 201 East North Street,** in **Greenville, South Carolina**, or at such other place as the holder of the note may designate in writing, in monthly installments of **Sixty Three and 87/100** ----- Dollars (\$ **63.87** ), commencing on the first day of **September**, 19**64**, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **August**, 19**94**.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of **Three Dollars (\$3)** to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**, State of South Carolina:

**ALL** that lot of land, with the buildings and improvements thereon, situate on the **East** side of **Waddell Street** and on the **West** side of **Finlay Street**, near the City of **Greenville**, in **Greenville County, S. C.**, being shown as **Lots 74, 75, 98 and 99** on plat of property of **B. Perry Edwards**, made by **R. E. Dalton**, Engineer, **May 1920**, recorded in the **R. M. C. Office for Greenville County, S. C.**, in **Plat Book F**, at **Pages 142 and 143**.
