All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being **on the Eastern side of Bedford Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 28 as shown on a plat of Heathwood, prepared by Dalton & Neves, dated July, 1956, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book KK at page 35, and having according to said plat the following metes and bounds:**
