All that certain, piece, parcel or lot of land with improvements thereon situate, lying and being on the Southwesterly side of Crosby Circle, near the City of Greenville, being shown as Lot No. 4 on plat of Paramount Park as recorded in the R.M.C. Office for Greenville County in Plat Book W, at Page 57.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
