WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of Choice Street in the City of Greenville, being shown as Lot 28, Oakland Heights, plat of which is recorded in Plat Book C at page 147, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Choice Street, 180 feet from the Northeastern corner of Oakland Avenue and Choice Street and running thence with Choice Street, S. 62-19 E. 60 feet to a pin at corner of Lot 29; thence N. 34-50 E. 150 feet to a pin; thence N. 62-19 W. 60 feet to pin; thence S. 34-50 W. 150 feet to the Beginning.
