WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Eight Thousand Five Hundred and No/100ths** -----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southern side of Miami Avenue in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lot No. 23 as shown on a plat of Springbrook Terrace, prepared by J. Mac Richardson, dated March, 1958, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book KK at page 143, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Miami Avenue at the joint front corner of Lots Nos. 21 and 23, and running thence with the line of Lot No. 21 S. 2-00 E. 150 feet to an iron pin in the rear line of Lot No. 22; thence with the rear line of Lot No. 22 N. 88-00 E. 28.8 feet to an iron pin at the joint rear corner of Lots Nos. 22 and 24; thence with the rear line of Lot No. 24 S. 85-03 E. 41.6 feet to an iron pin at the joint rear corner of Lots Nos. 23 and 25; thence with the line of Lot No. 25 N. 2-00 W. 155.1 feet to an iron pin on the Southern side of Miami Avenue; thence with the Southern side of Miami Avenue S. 88-00 W. 70 feet to the point of beginning.
