NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the city of Greenville, and being known and designated as Lot No. 24 of a subdivision known as Timberlake, Section III, a plat of which is of record in the RMC Office for Greenville County in Plat Book EE page 4, and having the following metes and bounds, to-wit:

Beginning at a point on the northern side of Old Spartanburg Road at the front corner of Lot 24, said point being 150 feet west of the northwestern intersection of Sedgefield Drive with Old Spartanburg Road, and running thence N. 11-31 W. 263.1 feet to a point at the rear corner of Lot 24; thence S. 76-11 W. 112.5 feet to a point at the joint rear corner of Lots 24 & 25; thence S. 13-37 E. 267.1 feet to a point on the northern side of Old Spartanburg Road at the joint front corner of Lots 24 and 25; thence with the northern side of Old Spartanburg Road N. 74-06 E. 103.4 feet to the point of beginning.

This loan is insured by American Mortgage Insurance Co. and it is understood and agreed that at the expiration of 10 years from the date of this mortgage, Fidelity Federal Savings and Loan Association may at its option, apply for insurance for an additional five years with American Mortgage Insurance Co., and the Mortgagor will pay to Fidelity Federal Savings and Loan Association a premium for such insurance of 1/2 of 1% of the principal balance then existing; and this agreement and covenant shall be binding on myself, my heirs, successors and assigns.
